2021 Streator's 4th of July Celebration Sponsorship Levels

VIDEO WALL ADVERTISEMENT: \$250 sponsorship level. Sponsor will receive a 0:15 second commercial on video walls, 2 social media posts, and 2 VIP Pit passes to every show.

SPARKLER LEVEL: \$500 to \$1499 sponsorship level. Sponsor will receive a 12' X 12' booth space or advertising space at North Point Shopping Center Field during the event, name listed on website, video wall advertisement, and 4 VIP Pit passes to every show.

FIRECRACKER LEVEL: \$1500 to \$2,999 sponsorship level. Sponsor will receive everything in the Sparkler level, plus included in all printed advertising materials, banner space at concerts and a total of 8 VIP Pit passes to every show.

VIP PIT LEVEL: \$5,000 to \$9,999 sponsorship level. Sponsor will receive a 0:30 second commercial on video walls at concerts, VIP logo-ed laminates *exclusive to this area, Sponsor listing on website, one weekly post on social media pages, company banners around VIP PIT fencing, and 15 VIP Pit passes to every show.

TITLE SPONSOR LEVEL: \$10,000 and up sponsorship level. Sponsor will receive a 0:30 second commercial on video walls at concerts, "YOUR COMPANY" Presents (On materials promoting the celebration), Namesake/Logo on main stage at the concerts, Logo/Names listed on all mentions of the celebration (digital and print), Sponsor listing on the website, one weekly post on social media pages, and 20 VIP Pit passes to every show.
